**Ordinance 47-20:** Introduced by Mastroianni: An Ordinance vacating a part of two twenty (20) foot alleys, bounded on the North by lot 12084, a 20' alley and lot 12085; bounded on the South by lot 5792 and outlot 87; bounded on the East by lot 11623, lot 11624 and outlot 87; bounded on the West by North Union Avenue/SR 183 in the City of Alliance, County of Stark, and State of Ohio.

**Ordinance 49-20:** Introduced by Lohnes: An Ordinance amending Alliance Codified Ordinance section 505 animals and fowl.

**Ordinance 51-20:** Introduced by King: An Ordinance accepting the proposed annual consolidated plan for the City of Alliance pursuant to the FY-2020 Community Development Block Grant Program in an amount not to exceed \$624,019.00; and declaring an emergency.

**Ordinance 52-20:** Introduced by Lohnes: An Ordinance authorizing and directing the Director of Public Safety and Service to enter into a contract for the purpose of purchasing two new police cruisers through the cooperative purchasing programs of the State of Ohio or to advertise for bids and enter into contracts with other vendors at the lowest and best price and to purchase necessary items to equip the cruisers, but for a cost not to exceed \$100,000.00 in any case; and declaring an emergency.

**Ordinance 53-20:** Introduced by Edwards: An Ordinance authorizing and directing the Director of Public Safety and Service to advertise for bids and enter into a contract at a cost not to exceed \$75,000.00 for the replacement of the Water Treatment Plant roof; and declaring an emergency.

**Ordinance 54-20:** Introduced by Mastroianni: An Ordinance accepting and approving the replat of all of Lots 7736, 7737, 7738, 7739 and 7740 located at 545 Buckeye Avenue, in the City of Alliance, County of Stark, and State of Ohio.
