Ordinance 59-21: Introduced by Cherry: An Ordinance authorizing and directing the transfer of nonproductive real estate not needed for any municipal purpose from the “City of Alliance” to the “City of Alliance – Land Reutilization Program”.

Ordinance 60-21: Introduced by _____: TBD

Ordinance 61-21: Introduced by King: An Ordinance adopting an emergency tree removal program pursuant to the Community Development Block Grant Program and authorizing the Safety Service Director to advertise for bids for the program.

Ordinance 62-21: Introduced by Grove: An Ordinance authorizing the Director of Public Safety and Service to advertise for bids and enter into contracts for the purchase of various supplies for the year 2022 to include options to renew where practical, or to accept existing options to renew; and declaring an emergency.

Ordinance 63-21: Introduced by Lohnes: An Ordinance appropriating funds for the purchase of two police vehicles; and declaring an emergency.

Ordinance 81-20: Introduced by Bugara: An Ordinance vacating all of a twenty (20) foot alley bounded on the North by Norfolk Southern Railroad; bounded on the South by Prospect Street; bounded on the East by part of lot 482; and bounded on the West by lot 2094 in the City of Alliance, County of Stark and State of Ohio.

Ordinance 82-20: Introduced by Bugara: An Ordinance vacating all of a twenty (20) foot alley bounded on the North by a twenty (20) foot alley; bounded on the South by lot 11829; bounded on the East by part of lot 231; and bounded on the West by lot 221 in the City of Alliance, County of Stark and State of Ohio.

Ordinance 86-20: Introduced by Council as a Whole: An Ordinance declaring the improvement to certain parcels of real property in the City to be a public purpose and exempt from taxation; providing for the collection and deposit of service payments and specifying the purpose for which those service payments may be expended; and authorizing compensation payments to the Marlinton Local School District.

Ordinance 48-21: Introduced by Mastroianni: An Ordinance accepting and approving the replat of lots 13004 and 13005 at 1992 Park Commons Circle, and the replat of lots 13010 and 13011 at 1987 Park Commons Circle in the City of Alliance, County of Stark and State of Ohio.
