Clerk Yost noted a couple of clerical errors that have been corrected in the official record. No additional deletions or corrections were offered by Council Members. Minutes were received and filed.

Announced the Veterans Council will again sponsor the POW-MIA day on September 23rd at 3:00 in Freedom Plaza.

Safety Service Director Dreger: Announced the paving project is set to start at the end of September or early October. Large crack repair work on the streets has already begun.

Reviewed Ordinance 66-18 and announced the administration had wanted action tonight since the application deadline is before the next meeting. Stated he doesn't believe formal passage of the Ordinance prior to application is necessary but if it is we will need to conduct a special meeting to address it.

Announced Stark Parks is starting a major improvement to the Deer Creek reservoir boat ramp and other improvements. This will likely cause a need to lower the water levels to accomplish it and the water department will closely monitor to watch for taste and odor problems that could be associated with the reduced water levels.

Law Director Arnold: Noted the request for an executive session to discuss pending litigation with no further report.

Auditor Knowles: Reviewed the Income tax recap and ordinance 65-18, since it can't be passed tonight there may be some line item adjustments prior to the next meeting and potential passage.

Chairman Grove then announced that he will send letters to both claimants regarding the decision of the Board as well as file a written report with the Clerk of Council.

Mr. Grove then adjourned the Claims Board meeting at 7:40 and President Garnes reconvened the Regular Council Meeting.
