

**MINUTES OF THE DECEMBER 16, 2019  
REGULAR MEETING OF THE ALLIANCE CITY COUNCIL**

The meeting was called to order by President Garnes at 7:00 P.M. Council President Garnes then gave the invocation and led the meeting in the Pledge of Allegiance.

**ROLL CALL:** Kris Bugara, James Edwards, Andrew Grove, Cindy King, Frank Minear, and Brian Simeone. Councilwoman Sheila Cherry arrived at 7:07.

#### **SECOND READINGS:**

**Ordinance 78-19:** Introduced by Grove: An Ordinance making temporary appropriations for 2020 for the General Fund, Water Fund, Sewer Fund and other City Funds, and authorizing the Auditor to draw payments from those appropriations upon receiving proper certificates and vouchers; and declaring an emergency. Motion and second to suspend the rule requiring 3 readings. Voice Vote: Unanimous. Motion and second to suspend the rule requiring Finance Committee review. Voice Vote: Unanimous. Motion and second to adopt. Voice Vote: Unanimous. **ADOPTED**

**Ordinance 79-19:** Introduced by Simeone: An Ordinance accepting and approving the replat of part of lot 2775 and all of lots 2776 and 2777 located at 114 South Street in the City of Alliance, County of Stark, and State of Ohio. **NO FORMAL ACTION**

**Ordinance 80-19:** Introduced by Council as a Whole: An Ordinance to approve the 2019 replacement pages to the Alliance Codified Ordinances; and declaring an emergency. Motion and second to suspend the rule requiring 3 readings. Voice Vote: Unanimous. Motion and second to adopt. Voice Vote: Unanimous. **ADOPTED**

**Ordinance 81-19:** Introduced by Simeone: An Ordinance accepting and approving the replat of all of lot 9279 and all of outlot 394 located at 1015 Fernwood Boulevard in the City of Alliance, County of Stark and State of Ohio. **NO FORMAL ACTION**

**NEW BUSINESS:**

**Ordinance 82-19:** Introduced by Minear: An Ordinance authorizing and directing the Director of Public Service to apply for Federal Emergency Management Agency (FEMA) Assistance for Firefighters Grant (AFG) in the amount of \$254,545 for the purpose of purchasing a new ambulance unit, and declaring an emergency. Motion and second to suspend the rule requiring 3 readings. Voice Vote: Unanimous. Motion and second to adopt. Voice Vote: Unanimous.

**ADOPTED**

**OLD BUSINESS:**

**Ordinance 68-19:** Introduced by Simeone: An Ordinance accepting and approving the replat of part of out lots 331, 356 and 357 located in the 900 block of West Ely Street (North/South sides), and all of out lots 47 and 48 and part of out lot 331 located at 562 West Ely Street in the City of Alliance, County of Stark, and State of Ohio. Motion and second to adopt with the intent to Defeat. Roll Call Vote: Unanimous. **DEFEATED**
