The meeting was called to order by President Garnes at 6:00 P.M. Councilman Bugara then gave the invocation and led the meeting in the Pledge of Allegiance.

Reviewed the Covid numbers for the year and compared them to the previous years

Reviewed the receipt of ARPA money and ways that it has been and is being applied.

Noted Alliance's selection as a finalist in the "All American City" competition.

Reviewed the City's Fiscal watch status and noted the need to renew the park levy

Stated that the Mall demolition is under way to make way for the new Meijer store

Reviewed the \$250,000 grant that the park got that resulted in the garage renovation and the new lodge. Stated that there is a second grant that is being used to renovate and improve and expand the skate park facilities.

Noted the completion of the City portion of the Iron Horse trail and stated that Stark Parks is still working on development of segments to City parks.

Informed Council of the formation of the Region 6 Opioid Committee and the Mayor's membership to that board to review and determine expenditure of the funds received

Stated that this year's NOPEC grant was for improvement of the HVAC units at the Courthouse which is a vast improvement over the old system.

Columbia Gas is continuing the replacement of lines and mains through the City

Reviewed the progress on the Lead Water line replacement project

Noted the work at repairing and improving the Martin Luther King Jr. viaduct and the expanded work of the committee and improving the whole downtown area.

Safety Service Director Dreger: Noted the need for a Water and Sewer Advisory Board meeting to discuss rates.

Reviewed Ordinance 003-23 and apologized for the lateness.

Noted the First Friday events coming up this weekend downtown

Law Director Weyer: Updated Council on the efforts of putting the park levy renewal on the spring ballot. Informed Council that Ordinance 089-22 will need amended before passage as there are some additional language changes set out by the Auditor due to the changes in the las.

Ordinance No. 003-23: Introduced by: Cherry: An Ordinance appropriating funds and authorizing and directing the Director of Public Safety and Service to advertise for bids and enter into contract(s) with a roofing contractor for the purpose of replacing the roof on the Alliance Senior Center, and renovating the cupola, but at a cost not to exceed \$110,000.00; and declaring an emergency. Motion and Second to suspend the rule requiring Finance Committee review. Roll Call Vote: Unanimous. Motion and Second to suspend the rule requiring three readings. Roll Call Vote: Unanimous. **NO FURTHER ACTION.**
