Motion and second to excuse Councilwoman Cherry who is ill. Roll Call Vote. **MOTION PASSED BY ACCLAMATION OF ALL MEMBERS.**

Safety Service Director Dreger: Informed Council that the annual hydrant flushing that normally takes place Memorial Day weekend will be delayed due to high MIB levels and algae treatment at the reservoir.

There has been a pre-construction meeting with North Star Paving regarding the summer paving program. Paving is expected to start in August but will be coordinated so not to interfere with Carnation Festival activities

Bret Fegan from Kimball Refuge was present and addressed Council on ongoing trash issues and answered questions from Council members regarding quality of service

President Garnes declared the Public Hearing closed at 6:24 PM and Council re-entered regular session

Ordinance No. 043-23: Introduced by Council as a Whole: An Ordinance accepting a Federal Emergency Management Agency (FEMA) Fire Prevention and Safety (FP&S) grant for the purpose of funding additional fire inspections and community risk assessment studies; authorizing and directing the Director of Public Safety and Service to enter into any necessary agreements; and declaring an emergency. Motion and second to suspend the rule requiring three readings. Roll Call Vote: Unanimous. **ADOPTED.**

Ordinance No. 044-23: Introduced by: Edwards: An Ordinance authorizing and directing the Director of Public Safety and Service to enter into contracts for right of way acquisition for the US-62/Beechwood/Sawburg intersection improvement project (STA-62-37.47 -pid 113209) for a sum not to exceed \$75,000; and declaring an emergency. Motion and second to suspend the rule requiring three readings. Roll Call Vote: Unanimous. **ADOPTED.**

Ordinance No. 045-23: Introduced by: Madison: An Ordinance authorizing and directing the Director of Public Safety and Service to advertise for bids and to award and enter into contract for the purchase of twelve Motorola APX6000 portable radios at a cost not to exceed \$64,000.00; and declaring an emergency. Motion and second to suspend the rule requiring three readings. Roll Call Vote: Unanimous. Motion and second to adopt. Roll Call Vote: Unanimous. **ADOPTED.**

Ordinance No. 046-23: Introduced by: Lohnes: An Ordinance approving the expenses incurred with the Kimble Company for residential garbage and recycling collection for December 2022 and the first quarter of 2023; and declaring an emergency. Motion and second to suspend the rule requiring three readings. Roll Call Vote: 5 to 1 (King). **NO FURTHER ACTION.**

Ordinance No. 047-23: Introduced by: Council as a Whole: An Ordinance establishing rates for residential garbage collection for July 1, 2023 through June 30, 2024; and declaring an emergency. Motion and second to suspend the rule requiring three readings. Roll Call Vote: 3 in favor (Edwards, Madison, Mastroianni) to 3 against (Bugara, King, Lohnes). **NO FORMAL ACTION.**

Ordinance No. 048-23: Introduced by: Council as a Whole: An Ordinance ratifying a memo of understanding (MOU) between the City of Alliance and the Fraternal Order of Police/Ohio Labor Council, Inc. (F.O.P./O.L.C), for the police clerical bargaining unit; and declaring an emergency. Motion and second to suspend the rule requiring three readings. Roll Call Vote: Unanimous. Motion and second to adopt. Roll Call Vote: Unanimous. **ADOPTED.**

Resolution No. 051-23: Introduced by: Council as a Whole: A Resolution congratulating the new president of the University of Mount Union and declaring May 12, 2023 to be "Gregory L. King Day" in the City of Alliance. Motion and second to adopt. Roll Call Vote: Unanimous. **ADOPTED.**

Ordinance No. 052-23: Introduced by: Council as a Whole: An Ordinance providing bonus payments from the American Rescue Plan Act (ARPA) funds allocated to the City to employees who work for the Alliance Municipal Court; and declaring an emergency. Motion and second to suspend the rule requiring three readings. Roll Call Vote: Unanimous. Motion and second to adopt. Roll Call Vote: Unanimous. **ADOPTED.**

Ordinance No. 053-23: Introduced by: Council as a Whole: An Ordinance authorizing and directing the Director of Public Safety and Service to extend the current sole provider contract for emergency medical and ambulance transport services within the city of alliance; and declaring an emergency. Motion and second to suspend the rule requiring three readings. Roll Call Vote: Unanimous. Motion and second to adopt. Roll Call Vote: Unanimous. **ADOPTED.**

Ordinance No. 054-23: Introduced by: King: An Ordinance accepting the proposed Annual Consolidated Plan for the City of Alliance pursuant to the FY-2023 Community Development Block Grant program in an amount not to exceed \$632,148.00; and declaring an emergency. Motion and second to suspend the rule requiring three readings. Roll Call Vote: Unanimous. **ADOPTED.**

Ordinance No. 055-23: Introduced by: Madison: An Ordinance approving the purchase of ammunition for training by the Alliance Police Department, but at a cost not to exceed \$40,000; and declaring an emergency. Motion and second to suspend the rule requiring finance committee review. Roll Call Vote: Unanimous. Motion and second to suspend the rule requiring three readings. Roll Call Vote: Unanimous. Motion and second to adopt. Roll Call Vote: Unanimous. **ADOPTED.**
